Manager Klemme informed the Board that the District employed aerial services to perform a "flyover" searching for unmaintained swimming pools. Approximately 300 pools were located with 40 being flagged as new unmaintained pools/hot tubs, etc. Staff is currently visiting the sites to evaluate/treat. Manager Klemme let the Board know the Santa Cruz office joined our staff in CPR training recently and all employees have updated certificates. UAS work is currently being performed and Klemme apprised the Board that at this time there are no human cases of West Nile Virus.

Trustee Carbone invited the Board to an event going on today at the Good Samaritan Center in Sand City where the city will rename a street in honor of the Shake family to Shake Ave.
